

CLERKS REPORT FOR FEBRUARY 8, 2016 BOARD MEETING

- Below is an email I received regarding unlicensed and uncontrolled dogs. The Animal Control Officer needs to be given direction on how to proceed with unlicensed dogs and uncontrolled dogs. The board passed the policies last year. We (Animal Control and myself) have been waiting to hear when he can start issuing tickets. It's time!!

"I wanted to give you an update on the dog issues - last week the husky dog was loose and was hit by a car - he got up and went back home. The neighbor across the street from the house (red house) she yelled to the owner of the dog to keep her %#!%# dog on their own property and they are sick of seeing it running around loose. The owner of the dog returned with \$#@!%^ as well. Our neighbor, xxxxx stopped over to see xxx today to find out about the dog - He gave her the dog warden's number to her today and will forward to the other neighbor. I wanted to call the dog warden but did not want repercussion with the neighbor that was swearing to them about keeping their dog on their property. Can the dog warden stop in and state there is an issue with their dogs and since they are not registered shouldn't they be getting a nice fine?"

- With your permission, I will be applying for a \$1000 grant to have some trees planted. Right now the consensus is to have some pines planted by the stream in Sunken Garden's park, and some lilacs planted at River View Park where there used to be lilacs.
